**Fire Chiefs** – Discussions on PIT CREW CPR from Dr. Mackey; information on changing parameters of SAFER Grant to include increasing the \$ for monthly performances; changing point scoring system for benefits, and purchasing PPE for new recruits

**Hazmat** – Hazmat FRO scheduled for firefighter academy, recently taught refresher for Central Fire

**Fire Training** – Operator training class completed, trying to schedule a S290 class but trouble coordinating a date to include a weatherman and avoid the Easter holiday weekend.

**Academy** - Need to re-schedule the auto extrication date, couldn't get enough donor cars to cut up; need instructor for S131 on 4/14; need instructors and engines for burn on 4/26-expected 14 students, burn building being built at Vallecito Camp, can leave in place for future use; structure burn planned for Douglas Flat on 4/1, need x2 engines, breathing support, and x1 water tender.
